## RE: School attendance dues and voluntary financial contributions 2021

Nau mai and welcome to 2021. As a parent/caregiver, we appreciate that you had a choice on the school you selected for your child's/children's education. We are honoured that you have chosen Marist Catholic School Herne Bay, and value the contribution you make to our special community.

Marist Catholic School, Herne Bay is different from other schools you may have considered:

- 1. First and foremost, we are a Catholic School and the Catholic Diocese charge to cover the cost for the Special Character education provided;
- 2. Furthermore, as an integrated school, we do not charge fees in any way comparable with private schools (e.g. about \$20k per annum); and
- 3. As an integrated school, we do not receive the same level of government funding as public schools; therefore
- 4. Therefore, we seek additional voluntary contributions from families to ensure we are providing your children with the best education possible.

Each year the Board of Trustees review the school fees. It is a challenging task to balance the increasing funding demands required to deliver a quality education for your children, with our desire to avoid putting undue financial pressure on families in our community.

After a detailed review, the Board of Trustees agreed to set the total contribution as follows:

- \$1,017 for the first child; and
- \$902 for any subsequent children of the same whanau enrolled at the school.

This fee contribution consists of the following components:

Building contribution	<ul> <li>Set by the MCSHB BoT.</li> <li>Ensures the school is able to invest in capital projects. Historically this has contributed to things like the new building, field drainage and landscaping. In 2021 these are expected to be new drinking fountains and cultural murals and items.</li> </ul>	\$90 per family
Family Assistance Fund	<ul> <li>Set by the MCSHB BoT</li> <li>In line with our values, this provides assistance to families who are experiencing financial difficulties;</li> <li>Contribution can be increased if families so desire.</li> </ul>	\$25 per family
